The quotations will be opened in the office of the undersigned at 2 P.M. on 10-08-2023.

- 2. The quotations shall be submitted according to the terms and conditions specified in paragraphs 3 to 12. Unless specified otherwise in the quotations, it shall be construed that the terms and conditions stipulated hereunder have been agreed to.
- 3. The rates should be F.O.R. and should include excise duty, sales tax, freight charges, any other taxes, rates or impositions which are leviable e.g., packing charges in respect of the supplies. The school/institution shall not be liable to pay any tax, freight, etc. which has not been expressly stipulated in the quotation in the event of acceptance of the quotation.
- 4. There should not be any overwriting or corrections in the quotation. If a figure is to be amended, it should be neatly scored out, the revised figure written above and the same attested with full signature and date. In the absence of such attestation the quotation is liable to be rejected.
- 5. The undersigned does not bind himself/herself to accept the lowest quotation and reserves the right to accept the quotation in whole or in part i.e., with respect to all the articles mentioned in the attached statement or in respect of one or more than one articles specified in the attached statementas he/she may decide.
